As this is the first year of work after the end of the studies cycle, André benefited from a substantial tax exemption in his IRS.

The exemption in the 1st year of income is 30%. As this amount is higher than the existing limit (3,324 euros), it was not possible to do it in full. Even so, we managed to make the application of IRS Jovem, allowing André to collect more 527.87 euros.

Having analysed both simulations made by Gabinete Rosa Barreto, we can see that, in addition to André meeting the requirements to enjoy this benefit, he can use the amount recovered from his application to buy the present he has been waiting so long to give his father.
